When writing about technical concepts we often use complicated language and terminology that can limit our audience's understanding and adoption of our messages. And we all know it is easier to write lengthy texts over many pages, than to fit our ideas into a few, concise sentences. Attend this interactive session and receive practical tips and guidance on how to write in plain language that is consistent, accessible and easy to understand.

In 2010, President Obama signed the Plain Writing Act, a law that requires federal agencies to use "clear Government communication that the public can understand and use." The Plain Language Action and Information Network (PLAIN) is a community of federal employees dedicated to the idea that citizens deserve clear communications from government (see <http://www.plainlanguage.gov/index.cfm>). Jessica Hartl, Acting Strategic Communications Team Leader at the Office of Food for Peace, USAID, will lead this session to help participants improve their writing.

## Evidence in Agriculture: Credit

Join The TOPS Program and [Becca Toole](#), Policy Associate of [MIT's Abdul Latif Jameel's Poverty Action Lab \(J-PAL\)](#), to answer the question: How might credit constrain smallholder farmers' adoption of new technologies? We will discuss smallholder farmers' credit needs and why traditional microcredit does not always meet them and share results of rigorous research (funded by the Agricultural Technology Adoption Initiative) that tested tailored credit products to better fit the context of smallholder agriculture. Some examples of promising credit products have provided improved information about borrowers to lenders, accounted for collateral constraints, or considered the seasonal distribution of farmer income. We will finish with a brief overview of digital financial services and a few key policy insights on credit for smallholders.

## Emergency Measurement Workshop: Lessons Learned from the Field

The emergency funding stream of the Office of Food for Peace (FFP) has been expanding quite fast over the recent years. As such USAID is interested in developing a more harmonized monitoring and evaluation guidance. To jump start FFP's reflection on this issue, TOPS was requested to organize a series of EFSP learning events to facilitate an initial sharing of M&E experiences. The DC event is the second one following the 2016 West African hosted in Burkina Faso.

The aim of the DC event is three fold:

1. Reflect upon useful methodologies and tools being used to track some of the standard indicators and other studies;
2. Learn from each other's successes and challenges; and
3. Provide useful feedback for USAID to provide better, more consistent technical assistance and oversight for the EFSPs.

## Seed System Security Assessment: Key Trainers Course Leading to Certification

September 15, 2017 - October 7, 2017

With increased global scrutiny focused on ill-tailored or dependency-generating seed responses, Seed System Security Assessments (SSSAs) are rapidly becoming the de-facto tool in preventing misdiagnosis of seed insecurity. Seed security is now widely seen as distinct from food security and there is growing worldwide interest in this new field of SSSAs.

With increased visibility, the demand for SSSAs is rising. Seed System Security Assessments have recently been integrated into USAID guidelines and standards for best practice and organizations like Catholic Relief Services (CRS) and the UN-Food and Agriculture Organization (FAO) are routinely commissioning actual field assessments. There is an urgent need to build a specialized set of experts who can lead such assessments worldwide.

This course will train in both rapid and more comprehensive forms of SSSAs. It will focus on a) analysis of all seed channels (own stocks, social networks, local networks, formal seed sellers) and b) targeted response options to deal with problems at hand. Tools will be both qualitative and quantitative (including options for automated data tallies and table formats). Methods for training will figure prominently as the aim to create a training of trainers capacity as well as to strengthen direct field assessments. Note that the focus will embrace different types of disaster, chronic stress and developmental contexts (see [seedsystem.org](http://seedsystem.org)).

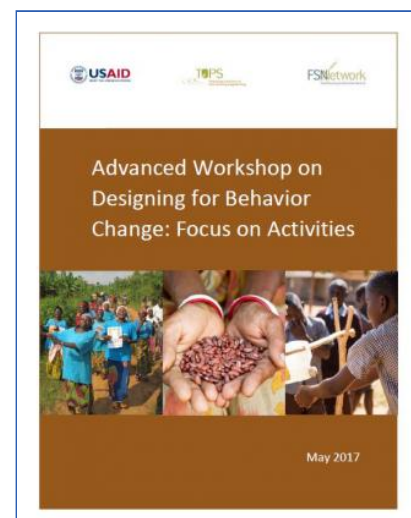
## Featured Resource

### Advanced Workshop on Designing for Behavior Change: Focus on Activities

During the past decade (2006 – 2016) many nongovernmental organization (NGO) staff have been trained to use the Designing for Behavior Change (DBC) framework to design determinant-based behavior change strategies. Review of completed DBC frameworks and discussions with practitioners indicated a desire and an opportunity for more in-depth discussion and practice in linking the results from their Barrier Analysis studies to effective activities.

In order to give appropriate emphasis and attention to the important step of designing activities that directly link to the results of formative research, The TOPS Program developed this three-day, additional curriculum for experienced DBC practitioners.
